# Barnett Elementary Nebo School District Title 1- Parent & Family Engagement Policy

In conjunction with Nebo School District, Barnett Elementary agrees to implement the following statutory requirements:

### PART I. GENERAL EXPECTATIONS

- The school district will put into operation, programs, activities and procedures
